3. Discussion with the Garda Commissioner of matters in the public domain

The Commissioner noted that she had offered to come to meet the Authority to clarify and to give Members an opportunity to ask questions about matters in the public domain It was noted that in addition to the usual constraints regarding live investigations, personal cases etc. the forthcoming Tribunal of Inquiry required particular care to be taken in any discussion.

The discussion gave Members an opportunity to deepen their understanding of relevant Garda Síochána practices and processes as a backdrop to matters in the public domain. Issues discussed included:

- Processes for evidence handling;
- Systems for assuring compliance with the "Children First Guidelines";
- How investigation cases are allocated to teams;
- Operation of disciplinary procedures;
- The challenges that recent events present for creating an environment in the Garda Síochána of speaking up and how that would be addressed in the short term;
- Welfare issues across the organisation;
- The value of the Public Inquiry (and by extension Authority meetings in public) providing the opportunity for maximum transparency;
- The absolute importance of maintaining a focus on delivery of policing and security services and implementing the modernisation and renewal programme;
- Necessity for review of legislation as it relates to GSOC functions; and
- How to change and renew culture in the Garda Síochána and the importance of progressing the culture audit so that success in this regard could be objectively measured.

The Chairperson alerted the Commissioner that the draft agenda for next week's Authority meeting would be amended in the context of the events of this past week.
